Minutes of the 44th Annual General Meeting of the Woolton Society held at Woolton Village Club, Allerton Road, Woolton on Wednesday 16th November 2016 at 7.30 pm.

Attendance:

The chairman welcomed all present and referred them to the meeting documents published in advance in the society's newsletter No 340, together with the statement of accounts for the year ended 31 August 2016 distributed at the meeting.

- 1. Notice convening the meeting. This was read by the chairman.
- 2. Apologies for absence. Apologies were noted from Peter Bates, Henry Stott, Sue Carmichael
- 3. Minutes of the 43nd Annual General Meeting held on 18th November 2015 and distributed in advance to all members were proposed as read by Mr Toke and accepted as a true record, on a show of hands.

4. The Hon. Treasurer's report

The hon treasurer Charles Davies presented the accounts for the year ending 31 August 2016 and commented on some items. The accounts showed a surplus for the year, due largely to the success of the publication of the Quarry Book. Another factor was the receipt of the first claim for gift aid. The accounts approved by the executive committee were accepted on a show of hands.

5. Chairman's remarks.

In lieu of a personal statement the chairman invited other officers of the committee to give a report for their areas of responsibility.

(i) The hon. secretary, Paul Wilkie reported that the executive committee met 7 times during the year, no additional members were co-opted, and there were no resignations. In the same period there have been 4 issues of the society's newsletter, ably edited by our chairman Jean Davies. Thanks are due to all involved in production and distribution of the newsletter. Viv Hicks organised another six outstanding talks, attracting very good attendances. This year the society again organised a visit, this time to the Williamson Tunnels.

This year saw the publication of "Woolton Stone and Liverpool Cathedral", marked by a launch event in June attended by the Bishop of Liverpool. The book has proved very popular, being sold by the society at talks, and on a stall on the Woolton farmer's market which we regularly take to recruit new members and publicise the work of the society. In addition Brown's Newsagents and the Cathedral bookshop are also stocking copies. The society has also produced a booklet "Who Lived in Woolton Hall", written by committee member Janet Hollinshead which is the first in what is hoped to be a series of booklets.

At the last AGM the issue of boundary changes was referred back to the committee. After consideration it was decided that we could not manage a significantly increased area, and since members were against reducing the southern area, we would have to leave the boundaries unchanged.

ii) The membership secretary Jean Bates reported membership (that is those who have paid their subscriptions) for the 2015/16 period peaked at 294 members. This did not quite match the bumper year we had last year with a total of 305 members but is still higher than the previous 7 years.

We also hold an electronic mailing list to allow the Woolton Society to email members with information on any of the campaigns the society is currently supporting or any events taking place.

We have 200 people on the electronic mailing list so far. If any of you have not given us your email address but would like to receive email notifications then please add your name and email to the sheet on the table after the meeting.

(iii) The environment secretary, Chris Darnton reported that the new St Julie's is now taking shape, and is much more dominating because it is closer to the village, and partly on a public park. The city council refuses to remove the rest of the field from the local plan. The promised donation of the woodland owned by the school appears to be heavily constrained, it seems that access will only be through a single gate located inside the walled garden.

Woolton Hall continues to deteriorate, but the owners seem reluctant to either develop or sell it.

On a more positive note, the sale of Woolton Golf course has now fallen through, the developer having failed to make the necessary payment.

If members are not happy with what is going on, don't rely on the single voice of the Society take ACTION yourselves. People need to object to planning applications, take the elected councillors to task as well as council officers responsible for protecting conservation areas and other public assets.

6. Election of officers.

Chairman: The current chairman Jean Davies offered her resignation from the committee and was nominated for the position of chairman, and duly re- elected.

Paul Wilkie offered his resignation from the committee, but stated he was willing to continue as vice-chairman, and was nominated and duly re-elected to the post.

In the absence of nominations for the role of hon. secretary, Paul Wilkie volunteered to continue in this role, until a candidate could be found and was duly elected.

Hon. treasurer: Charles Davies offered his resignation from the committee, but stated he was willing to continue and was duly re-elected.

Membership secretary: The current incumbent, Jean Bates offered her resignation from the committee, but stated she was willing to continue and was duly re-elected.

Environment secretary: The current incumbent Chris Darnton announced his resignation from the committee due to pressure of work. Committee member Janet Hudson was nominated for the post, and elected.

Bob Collins stood for election to the committee.

All the above were proposed, seconded and, there being no other nominations, were duly elected. The resignations form the officers met the requirements of the constitution for resignations.

7. Any other business.

7.1 Defibrillator

Dr Toke enquired whether the society had access to a defibrillator for meetings. The committee did not believe this to be the case, so Dr Toke offered to donate one to be dedicated to his late wife. The chairman offered to investigate this.

7.2 Thanks

Thanks were offered to those organisations which support the Society; the Village Club for the rooms for the talks and committee meetings, Riverside Screenprints Ltd. who have housed Janet Gnosspelius's archive for the society, and our accountants HBD Accountancy Services LLP.

The chairman thanked everyone for their attendance and closed the formal part of the meeting at 8.35 pm, when the appropriate officers signed the society's accounts.

Recent talks and walks

The talk on Thursday 13th July was experimental in nature, as it was the first to be held in the afternoon, & also at a different venue, the Simon Peter Centre on Church Road. The venture was hugely successful, as the speaker, Dr Andrew Zsigmond, attracted a packed audience who listened spellbound to his tale of the Hungarian uprising in 1956. After exchanging his text books for a gun, the then 20 year old medical student had to flee after the Russian invasion, reaching first Austria & eventually the UK. Here he learned to speak English at the cinema ("I began a sentence as David Niven & ended it as John Wayne...") & won a place at Liverpool's medical school. We thank Dr Zsigmond for an enthralling talk, & one which has ensured that we shall have several afternoon dates in the 2018 programme.

The guided walk on Sunday 30th July took a group of members around the Ropewalks area of the city centre, & was led by Blue badge guide Marie Passey. This was a very informative & entertaining tour, as we learned of the history of Duke Street, visiting the last back to back terraces in the city, on to Chinatown, then down the historic Georgian area around Parr & Colquit Streets & School Lane. Those on the walk will be well placed to answer many questions at the next Woolton Society quiz night, such as who was Duke Street named after? Thanks to Mrs Passey for such a fascinating tour.

Heritage Open Day on Saturday 9th September was marked by a guided walk around Woolton Village led by committee members. The walk started at the dolphin lamp, more properly the Rev. Leicester lamp, & progressed up Church Road via the Simon Peter Centre, St Peter's churchyard, the mere stones, Strawberry Field, Mendips & the old guarry workings. Fortunately the weather stayed dry, & the walk ended at the WI fete in time for tea & cakes.

Bill Sergeant gave the talk on Wednesday 20th September, with the nurses of the first war as his subject. Entitled Gallant Daughters of England, Mr Sergeant spoke movingly of the sacrifices these young women made in nursing overseas, & of the little known memorial to twenty of their number which is in the Anglican cathedral on Hope Street. Mr Sergeant's speaking fee has been donated at his request to the Royal College of Nurses benevolent fund.

In a change to our advertised programme Dr Tom Preston will be speaking on Liverpool's own Robb Wilton. 2018 programme

Society publications & merchandise

The Society now has four pamphlets & two books to its name, as well as tea towels & a new line of aprons.

The books are A History of Much Woolton, first published in 1975, reprinted in 2012, priced at £3, & Woolton Stone & Liverpool Cathedral, published in 2016 & costing £5.

The first three pamphlets are on Woolton Hall, Lord Woolton, & Hillfoot Villa, all written by committee member Dr Janet Hollinshead. Pamphlet 4 is a walk around Woolton, written by chairman Jean Davies, with illustrations by treasurer Charles Davies. All pamphlets are priced at £1.

The new aprons carry a design of local landmarks drawn by local artist Sandra Hepworth & are priced at £12. The tea towels, also featuring local views are £4.

All are available at Woolton Society talks, & at the farmers market stall on the second Saturday of the month. The books, but not the pamphlets or aprons, are also available at Brown's newsagent on Woolton Street.

Environment News

Woolton Hall

Although we do not report on Woolton Hall in every issue of the newsletter, it is a subject always of concern to us, as the Woolton Society was founded to prevent its demolition in 1972. The hall is becoming increasingly dilapidated, with regular reports of break ins & damage to the interior. At a committee meeting in July the three local councillors attended to discuss Woolton Hall. Cllr Bennett holds the responsibility for heritage, & is greatly concerned at the deterioration of the hall, which is one of only nine Grade 1 listed buildings in the city. Cllr Kelly has been very pro-active in contacting the current owners to discover their plans, if any, for future repairs & renovation. The WS environment secretary keeps in contact with planning officers has also tried to reach the owners several times. All requests for information have been ignored by the owners, & we are not aware of any planning applications for future work on the premises. We shall continue to press for information, & keep members informed of any progress.

The Istanbul restaurant

Issue 342 carried a report of the extension to the Istanbul restaurant on Allerton Road, which was repainted a vibrant shade of lilac entirely unsuited to a conservation area. After representations from the Woolton Society & many residents the owners were instructed to repaint the exterior. This has been completed & the restaurant now has cream brickwork much more in keeping with the neighbourhood.

Knolle Park

A fire at the Knolle Park site at the top of Church Road in the summer resulted in a significant drop in water pressure for residents after several tenders were called to the scene. Little damage was done to the main building.

There has been little sign of activity at the site, with residents receiving a letter some months ago concerning a city council enforcement order for roof repairs, etc. but with no news since then.

The planning applications have been held over for this issue owing to lack of space. The applications will be in issue 345 in early 2018.

In the past up to a dozen private gardens have been open, as well as the Bishops' Lodge, with refreshments provided by the W.I.
